



The Illinois Department of Employment Security (IDES) reported median

yearly wages for 2019 for four early care and education occupations (Educational Administrators of Preschools/Child Care Programs4, Kindergarten Teachers⁵, Preschool Teachers⁶, and Child Care Workers⁷) in three of the four counties in this report - Kankakee, Kendall, and Will.

Although the specific occupational definitions differed from IDES descriptions and the Illinois Salary & Staffing Survey descriptions, salaries were rather consistent with one another in that wages within IDES's preschool teacher and child care worker categories and the Illinois Salary & Staffing Survey child care staff categories were within the same range; however, it should be noted that the IDES's definition of child care worker includes a provider working in either a center or family child care home which is differentiated by the Illinois Salary & Staffing Survey.

Kindergarten teachers in Will County make double that of a preschool teacher or child care worker in the same county.

In both Kankakee and Will Counties, nursing assistants make more than preschool teachers and child care workers.

The median annual salaries of all child care providers in this report are

significantly below the median earnings of persons living and working in each county.¹ While individuals serving in administrative capacities in child care centers are most likely to receive wages above the county's median wage (between \$36,410 and \$39,520 for administrative directors and director/teachers), the majority of child care center teachers (\$29,120) and assistant teachers (\$22,880) are earning well below the median wage for employed persons in their county with family child care providers (\$20,800²) and school-age/teacher assistants (\$22,880) earning the least. When it comes to insurance and pension benefits, about three out of every four child care center staff members are provided partial or full coverage by their employer.

The median full-time, full-year salary of child care staff range from \$22,880 for assistant teachers/ school-age assistants to \$39,520 for administrative directors.

Teachers, 61.4% of whom have an associate's degree or higher, have a median annual salary of approximately \$27,040.

Half of surveyed family child care practitioners net \$12,000 or less annually.
