

The median annual salaries of all child care providers in this report are

below the median earnings of persons living and working in each county, with the exception of Ford County.¹ While individuals serving in administrative capacities in child care centers are most likely to receive wages above the county's median wage (between \$28,662 and \$43,260 for administrative directors and director/teachers), the majority of child care center teachers (\$26,166) and family child care providers (\$25,151²) are earning well below the median wage for employed persons in their county with school-age workers (\$20,280) and school-age assistants (\$20,800) earning the least. When it comes to insurance and pension benefits, about two-thirds of child care center staff members are provided partial or full coverage by their employer.

CHILD CARE STAFF RECEIVING BENEFITS / 2021





The Illinois Department of Employment Security (IDES) reported median

yearly wages for 2020 for four early care and education occupations (Educational Administrators of Preschools/Child Care Programs⁵, Kindergarten Teachers⁶, Preschool Teachers⁷, and Child Care Workers⁸) in two of the four counties in this report - Ford and McLean Counties.

Although the specific occupational definitions differed from IDES descriptions and the Illinois Salary & Staffing Survey descriptions, salaries were rather consistent with one another in that wages within IDES's preschool teacher and child care worker categories and the Illinois Salary & Staffing Survey child care staff categories were within the same range; however, it should be noted that the IDES's definition of child care worker includes a provider working in either a center or family child care home which is differentiated by the Illinois Salary & Staffing Survey.

The median full-time, full-year salary of child care staff range from \$20,280 for school-age workers to \$43,260 for administrative directors.

Teachers, 65.8% of whom have an associate's degree or higher, have a median annual salary of approximately \$24,960.

Half of surveyed family child care practitioners net \$20,000 or less annually.
