#### The median annual salaries of all child care providers in this report are

significantly below the median earnings of persons living and working in each county.<sup>1</sup> While individuals serving in administrative capacities in child care centers are most likely to receive wages above the county's median wage (between \$34,840 and \$39,520 for director/teachers and administrative directors)the majority of family child care providers, child care center teachers (\$31,200) and school-age workers (\$29,120) are earning well below the median wage for employed persons in their county with child care center assistant teachers (\$27,040) and school-age assistants (\$24,700) earning the least. When it comes to health insurance and pension benefits, around half of child care center staff members are provided partial or full coverage by their employer.

#### **CHILD CARE STAFF RECEIVING BENEFITS** / 2023






#### The Illinois Department of Employment Security (IDES) reported median

yearly wages for 2022 for four early care and education occupations (Educational Administrators of Preschools/Child Care Programs<sup>4</sup>, Kindergarten Teachers<sup>5</sup>, Preschool Teachers<sup>6</sup>, and Child Care Workers<sup>7</sup>) in four of the seven counties in this report— Madison, Monroe, Randolph, and St. Clair.

Although the specific occupational definitions differed from IDES descriptions and the Illinois Salary & Staffing Survey descriptions, salaries were rather consistent with one another in that wages within IDES's preschool teacher and child care worker categories and the Illinois Salary & Staffing Survey child care staff categories were within the same range; however, it should be noted that the IDES's definition of child care worker includes a provider working in either a center or family child care home which is differentiated by the Illinois Salary & Staffing Survey.

The median full-time, full-year salary of child care staff range from \$24,700 for school-age assistants to \$39,520 for administrative directors.

Teachers, 54.0% of whom have an associate's degree or higher, have a median annual salary of approximately \$29,120.

Half of surveyed family child care practitioners net \$12,000 or less annually.
